Details of Unified Payment Interface (UPI) IDs and FAQs (Pursuant to SEBI Circular No. SEBI/HO/DEPA-II/DEPA-II_SRG/P/CIR/2025/86 dated June 11, 2025)

Pursuant to SEBI Circular No. SEBI/HO/DEPA-II/DEPA-II_SRG/P/CIR/2025/86 dated June 11, 2025, we have generated the new Unified Payment Interface (UPI) ids for payment. The details of UPI ids and FAQs in this connection are given below:


1. UPI Id and QR scanner for adding the funds in Trading Account from registered Bank Account.

2. UPI Id and scanner for payment of all type of Demat Account Related Charges.

3. Purpose of New UPI Ids

Investors are requested to carefully note the specific purpose of each UPI Id before initiating any payment.

4. Payment through New UPI Ids

The investors can choose their preferred mode of payment, such as UPI, IMPS, NEFT, RTGS or Cheques. If an investor opts to use UPI for the payment, then they have to do so only using the new UPI Ids provided above.

Investor are also requested to mention their Unique Client Code (UCC) or Demat A/c No. in remarks while making the payment through New UPI Ids.

5. Payment through only Registered Bank Account

Investor making payment through new UPI Ids must take care that the payment should be made only from the registered bank account only.

6. What to check while making payment using the new UPI Ids/QR Code?

Investors need to keep the following things into consideration:

- 1. The UPI Id should properly show the name of the Company i.e. LSCSECURITIES, followed by the short abbreviation of category for example "brk" for Broker or dp for Depository Participant.
- 2. On the right side of the "@", the new and exclusive handle "@valid" should be present, followed by the bank name.
- 3. On the confirmation screen, the app should show a white thumbs-up icon inside a green triangle.
- 4. The QR code generated using the utility will have a white thumbs-up icon inside a green triangle. It will also display the UPI Id just below the QR code.

7. Whom to approach if case of transaction/payment fails with the new UPI Ids?

The secure validated UPI Id of the Company will use the same banking channel as the earlier generic UPI handles. In case of any technical difficulties, investors are requested to approach their respective bank.
