Postage will be borne and paid by the Company. However envelopes containing Postal Ballot Forms deposited in person or sent by post or courier at the expense of the Member will also be accepted.
- d) The signature of the Member on this Postal Ballot Form should be as per the specimen signature registered with the Company or the Depository Participant, in respect of shares held in physical form or dematerialised form, respectively.
- e) In case of joint holding, this Postal Ballot Form should be completed and signed by the first named Member.
- f) In case of shares held by Companies, Trusts, Societies etc., the duly completed Postal Ballot Form should be accompanied by a certified true copy of Board Resolution/ Authority Letter/Power of Attorney.
