- b) The voting rights of the Members shall be in proportion to their shares in the total paid-up equity share capital of the Company as on 30<sup>th</sup> September, 2022. Voting rights in the Postal Ballot cannot be exercised by a proxy.
- c) Members desiring to cast their votes by Postal Ballot may complete and sign this Postal Ballot Form and send it to the Scrutinizer in the enclosed postage prepaid self-addressed business reply envelope. Postage will be borne and paid by the Company. However envelopes containing Postal Ballot Forms deposited in person or sent by post or courier at the expense of the Member will also be accepted.
- d) The signature of the Member on this Postal Ballot Form should be as per the specimen signature registered with the Company or the Depository Participant, in respect of shares held in physical form or dematerialised form, respectively.
- e) In case of joint holding, this Postal Ballot Form should be completed and signed by the first named Member.
- f) In case of shares held by Companies, Trusts, Societies etc., the duly completed Postal Ballot Form should be accompanied by a certified true copy of Board Resolution/Authority Letter/Power of Attorney.
- g) Consent must be accorded by either placing a tick mark ( $\sqrt{}$ ) in the column 'I/We assent to the resolution' or dissent must be accorded by placing a tick mark ( $\sqrt{}$ ) in the column 'I/We dissent to the resolution.'
- h) Postal Ballot Forms which are incomplete or unsigned or defective in any manner are liable to be rejected.
- i) Duly completed Postal Ballot Form(s) should reach the Scrutinizer before the close of working hours i.e. 05.00 p.m. on 01st December, 2022 (Thursday). Postal Ballot Forms received after this date will be considered that no reply from such member has been received. In case of receipt of more than one Postal Ballot Form from a member, the last received Form would be considered and the earlier received Form(s) would be considered invalid.
